Under Rules 130 and 131 of its Rules of Practice, the Environmental Review Tribunal has directed the Approval Holder, Grand Renewable Wind LP / Grand Renewable Wind GP, and the Director, Ministry of the Environment, to give this Notice of Preliminary Hearing and Hearing.

NOTICE OF PRELIMINARY HEARING AND HEARING

In the matter of appeals by William Monture filed June 29, 2012, David Hyslop and Haldimand Wind Concerns filed July 3, and Janet Bard, Jim McCallum, and Joyce Smith filed July 5, 2012 for a hearing before the Environmental Review Tribunal pursuant to section 142.1 of the *Environmental Protection Act*, R.S.O. 1990, c. E.19, as amended with respect to a Renewable Energy Approval No. 0300-8UQPKR issued by the Director, Ministry of the Environment, on June 15, 2012 to Grand Renewable Wind LP / Grand Renewable Wind GP under section 47.5 of the *Environmental Protection Act*, regarding a renewable energy project consisting of the construction, installation, operation, use and retiring of a Class 4 wind facility with a total name plate capacity of 148.6 magawatts at a site located near Haldimand Road 20, in the County of Haldimand, Ontario.

The purpose of the Hearing is for the Tribunal to review the Director's decision and consider only whether engaging in the renewable energy project in accordance with the Renewable Energy Approval will cause serious harm to human health or serious and irreversible harm to plant life, animal life or the natural environment. If the Tribunal determines that such harm will be caused, the Tribunal may revoke the Director's decision; by order, direct the Director to take such action as the Tribunal considers appropriate; or alter the Director's decision, for which purpose the Tribunal may substitute its own opinion. If the Tribunal determines that such harm will not be caused, the Tribunal shall confirm the Director's decision.

Preliminary Hearing:

A Preliminary Hearing will be conducted by the Hearing Panel on Thursday, August 9, 2012 at 10:00 a.m. in the Council Chambers, Cayuga Administration Building, 45 Munsee Street North, Cayuga, Ontario. The purpose of the preliminary hearing will be to rule on requests from groups and individuals for party, participant or presenter status, to identify the issues to be considered at the main hearing and to deal with any preliminary matters that may be raised by parties, participants and presenters.

How to Participate:

Any person who wishes to participate in this hearing as a party, participant or presenter should provide their request in writing (preferably by email) to the Case Manager by 4:00 p.m. no later than **August 3, 2012** stating what status they are seeking; their interest in the proceeding; a statement of the issues, facts and submissions relevant to the appeal that they wish to present; and whether their participation is likely to make a relevant contribution to the Tribunal's determination of whether engaging in the renewable energy project in accordance with the approval will cause serious harm to human health or serious and irreversible harm to plant life, animal life or the natural environment. If a written request is not received by the required deadline, the Tribunal may refuse the request.

Main hearing

The hearing of evidence in this appeal will commence on Monday, September 10, 2012, at 10:00 a.m. at the Cayuga Kinsmen Community Centre, 15 Horburn Street, Cayuga, Ontario, and will continue, if necessary, on additional dates during the period September 11 to October 4, 2012.

There will be no reporting services provided by the Environmental Review Tribunal for the Hearing. If Parties consider that they require a transcript of the proceedings they may obtain such service at their own expense.

The Tribunal may make orders with respect to the conduct of the proceeding which will be binding on all present and future parties, participants and presenters.
