Grand Renewable Wind LP is proposing a minor technical change to the Grand Renewable Wind Project. The project is subject to the provisions of the *Environmental Protection Act (Act)* Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice must be distributed in accordance with the Regulation. This notice is being distributed to inform the public of a **proposed change to the project**. The project location is described in the map below.

## Project Description and Proposed Changes:

Pursuant to the Act and Regulation, the project is classified as a Class 4 Wind Facility. An application has been made to the Ministry of the Environment and Climate Change for a minor technical change to the project. This minor technical change consists of a minor realignment to a portion of access road associated with Turbine 53. The purpose of the realignment from the original application is to allow for the safe passage of construction and delivery vehicles during the construction phase.

If approved with these changes, the facility would still have a nameplate capacity 148.6 megawatts (MW) for the wind component. The project location, taking the change into account, is described in the map below.



## Documents for Public Inspection:

Completion of a Modifications Document was undertaken by Grand Renewable Wind LP to document where revision to the original REA application is required to incorporate this technical change application. This Modifications Document serves to update the supporting documents that are required to form part of the application submitted to the Ministry of the Environment and Climate Change.
