Southgate Solar LP is planning to engage in a renewable energy project in respect of which the issuance of a renewable energy approval (REA) is required. The proposed Southgate Solar Project (the "Project") would be located on multiple privately-owned parcels in the Township of Southgate, in the County of Grey.

The distribution of this notice as well as the project itself are subject to the provisions of the Environmental Protection Act (Act) Part V.0.1 and Ontario Regulation 359/09 (Regulation). This notice is being distributed in accordance with subsections 15.2 (1) and (2) of the Regulation after an application for a renewable energy approval has been submitted to and assessed for completeness by the Ministry of the Environment and Climate Change and has been posted on the EBR registry for public review (posting number 012-4349).

Project Description:

Pursuant to the Act and Regulation, the facility, in respect of which the Project is to be engaged in, is considered to be a Class 3 Solar Facility. If approved, this facility would have a total maximum name plate capacity of 50 MWac. The Project Location and all components will be located within the project boundary area as shown in the map. The final REA reports, prepared as part of the submission of a renewable energy application to MOECC for this project have now been posted on the proponent's website: <http://www.samsungrenewableenergy.ca/southgate>. They provide information on the proposed Project including location, components, activities and potential negative environmental effects.

Environmental Bill of Rights Registry Posting:

A proposal for a REA in respect of the Southgate Solar Project has been posted on the EBR Registry at www.ebr.gov.on.ca (as referred to in section 5 of the Environmental Bill of Rights, 1993). The posting number is 012-4349. Comments in respect of the proposal may be submitted to the Director (O. Reg. 521/10, s. 7).

The public has a **30 day review period** and must submit comments before the end of day on **July 12, 2015**.
