**Re: Sol-luce Kingston Solar PV Energy Project – Aboriginal Consultation Clarification, Renewable Energy Approval (REA) Application**

Thank you for your letter dated January 9, 2013 confirming that the Municipal Consultation, Agency Consultation, Natural Heritage Assessment Environmental Impact Study, Project Description Report, Design and Operations Report, and the Noise Study Report have been addressed and that you are further requesting clarification regarding Aboriginal consultation completed for the Sol-luce Kingston Solar PV Energy Project.

Kingston Solar LP considers communication with Aboriginal communities to be a valuable component in the development of this project as well as the REA process. As summarized in Section 5.2 of the Consultation Report (submitted as part of the REA Application for this project) and in the enclosed Aboriginal Communications Log, Kingston Solar LP has frequently corresponded with Aboriginal communities. Furthermore, throughout the course of the project Kingston Solar LP has expressed, on several occasions, its willingness to meet with Aboriginal community representatives to discuss the project and address their comments or questions. Kingston Solar LP will maintain this commitment throughout the development, construction and operation of the project.

Enclosed is an "Aboriginal Communications Log" providing Kingston Solar LP's efforts to engage with the Aboriginal communities, to date.

In your January 9th letter you requested clarification on items from the Consultation Report regarding Aboriginal consultation and indicated that:

*"The Consultation Report showed that the Aboriginal communities were only provided with the Notice of the First Public Meeting after the meeting had been held."*

### **Proponent Response**

On July 26, 2011 Kingston Solar LP submitted the draft Project Description Report to the Ministry of Environment requesting an Aboriginal Community List.

On July 28, 2011 in advance of receiving the Ministry's Aboriginal Communities List Kingston Solar LP proactively issued Notice of the First Public Meeting to the following seven (7) communities:

1. Algonquins of Pikwàkanagàn ;
2. Ardoch Algonquin First Nation;
3. Mohawk Council of Akwesasne;
4. Mohawks of the Bay of Quinte (Tyendinaga Mohawk Council);
5. Shabot Obaadjiwan First Nation;
6. Wendat (Hurons) of Wendake; and,
7. Métis Nation of Ontario (MNO).

On August 29, 2011 the Ministry of Environment provided Kingston Solar LP with the Aboriginal List identifying the following communities:

- Alderville First Nation;
- Curve Lake First Nation;
- Hiawatha First Nation;
- Kawartha Nishnawbe;
- Mississaugas of Scugog Island First Nation; and
- Mohawks of the Bay of Quinte (Tyendinaga Mohawk Council).

On October 3, 2011, Kingston Solar LP provided the identified Aboriginal communities with the Notice of Proposal to Engage in a Renewable Energy Project and Notice of Public Open House. Letters of Proposal and accompanying Notices were also sent to the identified Aboriginal communities. Kingston Solar LP followed up with a telephone call to each community which received a Notice of Proposal to obtain comments. The First Open House was held on August 30<sup>th</sup> and 31<sup>st</sup>.

All of the above listed communities have been subsequently contacted by Kingston Solar LP on numerous occasions. The level of effort to communicate with these communities about the proposed Project is provided in the enclosed "Aboriginal Consultation Log".

To date Kingston Solar LP received responses from three (3) of the communities listed by the Ministry, namely: Hiawatha First Nation, Curve Lake First Nation, and Alderville First Nation. Neither expressed concerns with the Project. No comments were received from Kawartha Nishnawbe First Nation, or Mississaugas of Scugog Island First Nation.

In your January 9th letter you had also indicated that:

*"The Consultation Report also showed that the Notice of the Second and Final Public Meeting was provided 19 days prior to the meeting, when the regulation requires it to be submitted at least 60 days prior to the meeting".*

### **Proponent Response**

The First Notice for the Final Open House was included as an enclosure with the June 13, 2012 letter (provided in "Appendix M" of the Consultation Report). This First Notice was sent to each of the Aboriginal communities 62 days in advance of the Second and Final Open House. The Notice is enclosed please refer to "First Notice of Final Open House".

As recommended in your letter and discussed with your staff, Kingston Solar LP will be providing a letter to each of the Aboriginal communities to verify whether Kingston Solar LP has considered, addressed, and communicated any adverse impacts to their Aboriginal and treaty

rights including how the impacts will be avoided, minimized and/or mitigated. We will also be following up with telephone calls to these communities.

Despite numerous attempts to contact the identified Aboriginal communities, to date, Kingston Solar LP has received no specific information in regards to potential adverse effects that the project could have on the constitutional and/or treaty rights of these communities.

As part of our ongoing efforts to continue an open dialogue with Aboriginal communities we have enclosed copies of "Project Update Letters" that we will be sending out this week to the all of the Aboriginal communities we have communicated with to date.

Furthermore we have enclosed a "Notice of Stage 4 Archaeology Assessment" letter which was sent on September 14 2012 to all the identified aboriginal communities stating that all stage 3 Archaeology Assessment (AA3) was completed and stage 4 (AA4) was to resume during the month of September (2012).

I trust that the above information satisfies the Ministry's comments with respect to Kingston Solar LP's consultation with the Aboriginal communities. 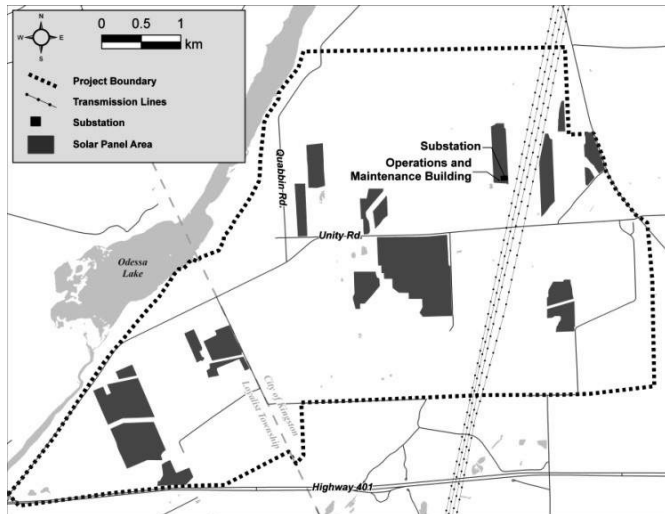

Dear Chief, Council and Members of Community:

As part of the ongoing work to complete the required studies for the Renewable Energy Act (REA) approval under the *Green Energy Act*, Stage 1, 2 and 3 archaeological assessments have been completed on participating properties in the study area by AMEC Environment & Infrastructure (AMEC) and Golder Associates Ltd. (Golder) on behalf of Kingston Solar LP. These reports, which have been submitted to the Ontario Ministry of Tourism, Culture and Sport (MTCS), are available upon request. The purpose of this letter is to inform you of the Stage 4 mitigation that Golder will commence in September at three locations (BdGd-50, BdGd-51, and BdGd-52) within the Sol-Luce Kingston Solar PV Energy Project study area. The following section summarizes the results of the Stage 3 assessments at these three historic Euro-Canadian sites. It should be noted, that the material cultural remains recovered at BdGd-50, BdGd-51, and BdGd-52 to date do not suggest the presence of Aboriginal material. Site BbGd-48, also subject to Stage 3 assessment and recommended for Stage 4 mitigation, is currently not to be impacted by the Project footprint; measures will be undertaken to ensure this site is protected from ground disturbing activities. It should be noted, that the material cultural remains recovered at BdGd-48 to date do not suggest the presence of Aboriginal material.

The Stage 3 assessment of BbGd-50 resulted in the recovery of primarily early to mid-19<sup>th</sup> century Euro-Canadian artifacts. The ceramic assemblage includes predominantly pearlware and whiteware ceramics. Additional artifacts characteristic of an early to mid 19<sup>th</sup> century historic site were also recovered including hand wrought and machine cut nails and white clay pipe fragments. The remains of a log structure were identified in relation to the artifact scatter and are considered to be a part of BbGd-50. BbGd-50 is considered to have a high level of cultural heritage value or interest due to the information it could lend to the understanding of settlement and land use in 19<sup>th</sup> century rural Ontario.

The Stage 3 assessment of BbGd-51 resulted in the recovery of primarily early to mid-19<sup>th</sup> century Euro-Canadian artifacts. The ceramic assemblage includes predominantly pearlware and whiteware ceramics. Additional artifacts characteristic of an early to mid-19<sup>th</sup> century historic site were also recovered including hand wrought and machine cut nails and white clay pipe fragments. BbGd-51 is considered to have a high level of cultural heritage value or interest due to the information it could lend to the understanding of settlement and land use in 19<sup>th</sup> century rural Ontario.

The Stage 3 assessment of BbGd-52 resulted in the recovery of primarily early to mid-19<sup>th</sup> century Euro-Canadian artifacts. The ceramic assemblage included predominantly pearlware

and whiteware ceramics. Additional artifacts characteristic of an early to mid-19<sup>th</sup> century historic site were also recovered including hand wrought and machine cut nails, white clay pipe fragments and a coin dating to 1820. BbGd-52 is considered to have a high level of cultural heritage value or interest due to the information it could lend to the understanding of settlement and land use in 19<sup>th</sup> century rural Ontario.

As was noted above, Golder will commence the Stage 4 mitigation of sites BdGd-50, BdGd-51, and BdGd-52 in September. This will include the hand excavation of a series of one metre square units in the areas of greatest artifact density. All soil that is excavated will be screened through 6 millimetre mesh with all artifacts retained and returned to the laboratory for analysis. Following the hand excavation of units the topsoil across the site will be mechanically removed using an excavator and all subsurface cultural features will be photographed, drawn and excavated. The recovered artifacts will be analyzed and reported on in accordance with the 2011 *Standards and Guidelines for Consultant Archaeologists*.

As sites BdGd-50, BdGd-51, and BdGd-52 date to the historic Euro-Canadian period, the potential for the recovery of pre-contact or post-contact Aboriginal material during the Stage 4 mitigation is very low.
